MINUTES

A meeting of the WVRIFA Participation Committee for the Wood Haven Road Project was held on Friday, September 20, 2019 at 10:00 a.m. at the Roanoke Valley-Alleghany Regional Commission office (Top Floor Conference Room), 313 Luck Avenue, SW, Roanoke, VA.

1. CALL MEETING TO ORDER

Chairman Cowell called the meeting to order at 10:00 a.m.

2. ROLL CALL

Chairman Cowell welcomed those in attendance and asked Virginia Mullen to call the roll. Ms. Mullen noted that a quorum was present.

Participation Committee Members Present: James Taliaferro, City of Salem; Bob Cowell, City of Roanoke; and Dan O'Donnell, Roanoke County.

Staff Present: Beth Doughty, WVRIFA Director; John Hull, WVRIFA Assistant Director; Sam Darby, WVRIFA Counsel; Sherry Dean and Virginia Mullen, WVRIFA Finance/Administrative Staff.

3. APPROVAL OF THE JULY 19, 2019 PARTICIPATION COMMITTEE MINUTES

The July 19, 2019 Participation Committee Minutes were distributed earlier.

Motion: by Dan O'Donnell to approve the Minutes of the July 19, 2019 Participation Committee meeting, as presented. The motion was seconded by James Taliaferro.

4. PUBLIC COMMENT PERIOD

5. CONSIDERATION OF PROPOSED CONTRACT FOR ENGINEERING SERVICES

John Hull reported that the Authority had put out a request for proposal for additional engineering services, supporting Phase 1 development of the Park. Distributed with the agenda are a) Term Engineering (Master) contract agreement with Balzer and Associates for additional engineering services and b) Pad Design Work and Permitting Contract Agreement. The Master contract enables the Authority to cover roughly three years of engineering services, potentially required for the Woodhaven project, without additional advertising and procurement actions. The contract does not obligate the Authority to proceed with any of the elements of the contract. In addition, every project would have to be specifically authorized after a cost and scope proposal. Staff recommended forwarding the contract agreements to the full Authority Board for approval.

Motion: by Dan O'Donnell, seconded by James Taliaferro, recommending that the full WVRIFA Board approve the Term Engineering Contract Agreement with Balzer and Associates, Inc, as presented.

The motion was seconded by James Taliaferro. The motion was adopted and carried by a vote of 3 to 0. The WVRIFA Participation Committee went into a Closed Meeting at 10:09 a.m.

9. ACTION BY THE PARTICIPATION COMMITTEE AS A RESULT OF THE CLOSED MEETING

There was no action as a result of the discussion at the closed meeting.

10. UPDATE ON WATER/SEWER CONSTRUCTION PROJECT

Hull reported that three weeks ago E.C. Pace initiated work and immediately encountered a significant volume of rock. E. C. Pace performed test drilling at their expense to determine the volume. E.C. Pace had also consulted with Balzer and Associates, Inc. to determine how to resolve the problem. E.C. Pace had estimated that it would cost around \$149,000.00 to remove the rock from the area and about \$16,500.00 for additional rock removal to accommodate future turn lane construction.

Motion: by Dan O'Donnell, seconded by James Taliaferro, recommending that the full WVRIFA Board authorize staff to negotiate change of orders of up to \$200,000, should additional work be required.

11. **OTHER BUSINESS**

Doughty reported closing on the Bower property. Mr. Bower will vacate the property by September 18, 2020. The Authority's agent is holding \$20,000 of the purchase price in escrow to be delivered when the property is vacated.

Doughty reported that a phone number for questions was established and provided in a mailing to nearly two thousand residents. The number is 540 266-4941 and listed on www.wvrifa.org and the new Facebook page (<https://www.facebook.com/WVRIFA/>). The intent is to provide opportunities for communication. In addition, staff had made several personal phone calls to residents most affected by the construction. She noted that a drone video of the Woodhaven property was created by RVTV and showed it at the meeting.
