

MINUTES

A meeting of the WVRIFA Participation Committee for the Wood Haven Road Project was held on Friday, November 19, 2021 at 10:00 a.m. at the Roanoke Valley-Alleghany Regional Commission office (Top Floor Conference Room), 313 Luck Avenue, SW, Roanoke VA.

1. CALL MEETING TO ORDER
