

### **MINUTES**

The April meeting of the WVRIFA Participation Committee for the Wood Haven Road Project was held on Thursday, April 28, 2022 at 10:00 a.m. at the Roanoke Valley-Alleghany Regional Commission office (Top Floor Conference Room), 313 Luck Avenue, SW, Roanoke VA.

**NOTE:** The April 28,2022 Meetings of the WVRIFA Participation Committee and the WVRIFA Board of Directors were held simultaneously (jointly) since several items on both agendas were the same.

## 1. <u>CALL MEETING TO ORDER</u>

Chair Cowell called the meeting to order at 10:00 a.m.

## 2. ROLL CALL

Chair Cowell welcomed those in attendance and asked Virginia Mullen to call the roll. Ms. Mullen noted that a quorum was established.

<u>Participation Committee Members Present</u>: Rob Light, City of Salem; Bob Cowell, City of Roanoke; and Richard Caywood, Roanoke County.

## 3. ACTION NEEDED: APPROVAL OF THE CONSENT AGENDA ITEMS

The following consent agenda items were distributed earlier: (A) March 18, 2022 WVRIFA Board Minutes and (B) Financial Reports as of March 31, 2022.

<u>Motion:</u> by Rob Light to approve the consent agenda items (A) and (B), as distributed. The motion was seconded by Richard Caywood.

WVRIFA Participation Committee Action: Motion carried.

# 5. <u>ACTION NEEDED: APPROVAL OF BOND TO SUPPORT INOVATION DRIVE IMPROVEMENTS</u>

John Hull reported that the bond letter (distributed with the agenda packet) is intended to replace a bond that Bowman Excavating Inc. has held for the Innovation Drive project. The Innovation Drive Road will not be accepted in the state system until there is suitable level of traffic, generated on that road. It is required by Roanoke County the bond to be held until that is accomplished. The letter of credit that is in the agenda packet allows the Authority to assume responsibility for the bond.

Mr. Caywood asked if the road could meet the service requirements as a single user. Mr. John Hull replied that he would follow up with VDOT on the road acceptance guidelines.

<u>Motion:</u> by Richard Caywood to recommend to the WVRIFA Board the approval of the bond letter, as presented. The motion was seconded by Rob Light.

WVRIFA Participation Committee Action: Motion carried unanimously.

### 6. <u>VEDP CONTRACT BUFFERING</u>

John Hull presented plans from Balzer for additional landscaping, that would utilize the VEDP funds (the contract was distributed with the agenda packet pages 21 through 34). The plan includes planting 48 colorado blue sprues, 13 green giant arborvitae and 114 leyland cypress.

<u>Motion:</u> by Rob Light to recommend to the WVRIFA Board the approval of the VEDP contract, as presented. The motion was seconded by Rob Light.

WVRIFA Participation Committee Action: Motion carried unanimously.

## 7. PROJECT UPDATE

John Hull reported that the Authority had made final payment on the grading project with Bowman Excavating and the project is complete.

### 8. REQUEST FOR CLOSED MEETING

Motion was made by Richard Caywood that the Committee convene in a Closed Meeting to discuss the potential disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body, pursuant to section 2.2-3711 A. 3. of the Code of Virginia (1950), as amended. The motion was seconded by Rob Light. The motion was adopted and carried by a vote of 3 to 0. The WVRIFA Participation Committee went into a Closed Meeting at 10:20 a.m.
