WESTERN VIRGINIA REGIONAL INDUSTRIAL FACILITY AUTHORITY DRAINAGE IMPROVEMENT PROJECT WOOD HAVEN TECHNOLOGY PARK

The purpose of this project is the removal of approximately 1,335 linear feet of existing drainage channels to prepare the site for additional future grading and development. The project is located within the Wood Haven Technology Park on Wood Haven Road in the County of Roanoke. The disturbance to the channels has been permitted and mitigated with Virginia DEQ as required and all construction shall follow the requirements in the DEQ permit.

The project will include clearing and grubbing operations, earthwork operations, erosion and sediment control measures, installation of gravel underdrains, storm sewer, and construction of a new ditch line as indicated on the construction plans entitled "Wood Haven Technology Park Drainage Improvements." The project will also include stabilization of eroded areas within a storm water detention basin.

The project completion deadline is February 28, 2026.
